**Use:** Adjuvant

**Substance:** Green liquid containing 81.5 g/litre of Alcohol Ethoxylate (CAS 84133-50-6).


**WARNING**

<b>Tanker/Vehicle Accident</b>	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. <b>Call the emergency services: Dial 111.</b>	
<b>Spill or leak</b>	<p>For Hazardous Materials [or Dangerous Goods] Incidents, Spill, Leak, Fire, Exposure, or Accident Call CHEMTREC day or night, within New Zealand: +64 9-801 0034, outside New Zealand: +1(703)527-3887.</p> <p>Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Take precautionary measures against static discharge. Use only non-sparking tools. Keep combustibles (wood, paper, oil, etc.) away from spilled material. Prevent product from entering drains.</p> <p><b>Large Spills:</b> Stop the flow of material if this is without risk. Dike the spilled material, where this is possible. Use a non-combustible material like vermiculite, sand, or earth to soak up the product and place into a container for later disposal. Following product recovery, flush area with water.</p> <p><b>Small Spills:</b> Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal.
