COMPATIBILITY

Test for compatibility prior to mixing and application with other chemicals. Always test new tank-mix combinations before widespread use.

MIXING

To ensure thorough mixing, recirculate mini tanks and bulk tanks or shake containers before using. Pre-rinse all tanks, spray lines or containers before adding TRANSFORMER as TRANSFORMER contains surfactants. TRANSFORMER should not be added to tanks, spray lines or containers which may contain additional surfactant / adjuvants. Coatings on inner tank and spray lines from previous chemicals sprayed, may be dissolved by TRANSFORMER. When applying as a soil spray, add water to the spray tank until nearly full, then add TRANSFORMER and agitate gently to ensure mixing with minimal foam generation.

APPLICATION AND DOSAGE RATES

Early spring applications are most effective followed by repeat applications as needed. Apply TRANSFORMER at 10 litres per hectare through furrow, flood, micro-jet, sprinkler jet and other irrigation systems. It can also be applied in conjunction with most types of liquid fertiliser. In addition, it can be applied as a soil spray. When metering TRANSFORMER directly into an irrigation system by means of a metering injection pump or suction regulated line, do not connect to an irrigation system used for chemical applications or directly to a public water system without a back siphon prevention system in place.
