Check for spills, leaks. Tanker/Vehicle Call the emergency services: Dial 111 Accident Spill or leak Keep all bystanders away. Wear goggles, half face-piece respirator with combined dust and vapour cartridge, full length clothing and PVC gloves. Sweep up spilled product and place in a sealable container for disposal.
